

CONTRIBUTORS: SHORT BIOGRAPHIES

SUSAN ALCOCK

Dr Susan Alcock is Assistant Professor in Classical Studies at the University of Michigan, and was previously Lecturer in Archaeology and Classics at the University of Reading. She took her PhD at Cambridge University in 1989 with a thesis examining social and economic change in Greece following the Roman conquest. Her primary research interests include the regional field survey, landscape archaeology and problems of ritual geography, especially in the context of the Hellenistic and Roman East.

SIMON CLARKE

Simon Clarke obtained his first degree from the Department of Archaeological Sciences, the University of Bradford; he is there currently completing his PhD entitled A Regional Archaeological Study of the Severn-Cotswolds Region from the Iron Age to the Early Saxon Periods.
